JUDGMENT AGAINST DEFENDANT PEGGY L. WALKER

Following the order of default judgment entered against Defendant Peggy L. Walker on December 31, 2007, the Court gave notice of a hearing on damages set for March 5, 2008. At this hearing, Plaintiff presented evidence of its damages through the testimony of its Vice President, Tim Donovan, and its legal counsel, Henry M. Perlowski, as well as through the exhibits admitted into evidence. Defendant Peggy L. Walker failed to appear at this hearing.

Upon consideration of all matters of record, the testimony and exhibits tendered during the above-referenced hearing, and applicable law, the Court hereby finds that Plaintiff sustained actual damages in the amount of \$1,034,824.74, which includes the amounts embezzled from Plaintiff's accounts by Defendant Peggy L. Walker and the additional auditor costs sustained by Plaintiff in responding to these acts of embezzlement. Plaintiff's actual damages then shall be trebled to \$3,104,474.22 pursuant to 18 U.S.C. § 1964(c) and O.C.G.A. § 16-14-6(c). Plaintiff furthermore is entitled to its attorneys' fees and expenses pursuant to 18 U.S.C. § 1964(c) and O.C.G.A. § 16-14-6(c), which total \$20,740.48.

Accordingly, it is hereby **ORDERED AND ADJUDGED** that a judgment by default is granted to Plaintiff against Defendant Peggy L. Walker in the sum of \$3,104,474.22 for trebled actual damages and \$20,740.48 for recovery of reasonable attorneys' fees incurred by Plaintiff.
